Monterey Regional Airport's Big Sur International Marathon Race Entry Prize Contest

<u>General Description:</u> The Big Sur International Marathon Race Entry Prize Contest (the "Contest") is conducted by the Monterey Regional Airport hereinafter referred to as MRY. To participate in the Contest, participants must have previously entered into the Big Sur International Marathon Foundation's giveaway on behalf of MRY and United Airlines. Participants must follow the link provided on the contest email and complete the webform on the MRY website. Refer to the entry paragraph below for more information. Upon entry, all participants unconditionally agree to and accept these Official Contest Rules.

<u>Eligibility:</u> The Contest is open to all California residents age eighteen (18) and over except where prohibited or restricted by law, who have agreed to these Rules and have previously entered into the Big Sur International Marathon Foundation's giveaway on behalf of MRY and United Airlines. Employees, contractors, directors and officers of MRY and their respective parent, subsidiaries, or affiliated companies, distributors, advertising and promotion agencies, judging and other agencies (if any) involved in the administration, fulfillment and execution of this Contest and the immediate family members, and/or those living in the same household of each such employee, contractor, director and/or officer are not eligible to enter or compete in the Contest.

Entry: Entrants must be a recipient of MRY's email blast advertising the Contest. Recipients of the Contest email are individuals who have previously entered into the Big Sur International Marathon Foundation's giveaway on behalf of MRY and United Airlines and selected that they would like to receive emails from Monterey Regional Airport. Participants must follow the link provided on the contest email and complete the webform on the MRY website. Webform details include name, email address, phone number (to contact if chosen as winner), shirt size, and race preference. Participants must also provide a brief description of why they would like to be part of the Monterey Regional Airport and United Airlines running team.

After successfully completing these Actions, said entrant will then receive one (1) entry into the Contest ("Webform Entry"). All Actions must be completed fully to be valid. Entry form must be submitted by 11:59 PM on Monday, February 17, 2020.

Winners will be chosen by Monterey Regional Airport staff. The ten (10) chosen winners will each receive one (1) entry to the race of their choice (participants must choose between the Big Sur Marathon, 21 Miler or 11 Miler) taking place on April 26, 2020. Winners will be notified on Tuesday, February 18, 2020 via email and/or phone call.

By registering, each participant agrees to release, discharge, defend and hold harmless MRY, its parents, subsidiaries, affiliated companies, licensees, and assigns, and its respective officers, directors, employees, agents, and representatives from any claim or liability arising from or related to submitting an entry.

There are ten (10) Contest Prizes:

10 - One (1) entry into the Big Sur Marathon, 21 Miler or 11 Miler including one (1) MRY / United Airlines running team shirt. Approx. value: \$40.00 for running team shirt and \$130.00-\$200.00 per race entry, depending on choice of race.

<u>Winners</u>: A winner of a prize is not declared a winner unless and until the participant's eligibility is verified and confirmed under these Official Contest Rules.

The selection of the winners of the prizes will be final and binding. Winners are responsible for all associated costs of participating in the Big Sur Marathon including but not limited to lodging and transportation.
