

## OFFICIAL CONTEST RULES

### Monterey Regional Airport's trip giveaway to Denver, Colorado

Winners will be chosen by Monterey Regional Airport staff. The winner will be notified on Tuesday, October 2, 2018 and invited to the Denver Inaugural Flight Celebration on Thursday, October 4, 2018 from 12:00 PM to 2:00 PM to claim their prize at the Monterey Regional Airport. Celebration details will be provided to the winner.
