

## OFFICIAL CONTEST RULES

### Monterey Regional Airport's Giveaway to Run the 2023 Big Sur International Marathon

#### BIG SUR INTERNATIONAL MARATHON RACE ENTRY GIVEAWAY

**General Description:** The Big Sur International Marathon Race Entry Giveaway (the "Contest") is conducted by the Monterey Regional Airport, hereinafter referred to as MRY. To participate in the Contest, participants must enter by completing the entry form at [montereyairport.com/marathon-giveaway](https://montereyairport.com/marathon-giveaway). Upon entry, all participants unconditionally agree to and accept these Official Contest Rules.

**Eligibility:** The Contest is open to all California residents age eighteen (18) and over except where prohibited or restricted by law, who have agreed to these Rules. Employees, contractors, directors and officers of MRY and their respective parent, subsidiaries, or affiliated companies, distributors, advertising and promotion agencies, judging and other agencies (if any) involved in the administration, fulfillment and execution of this Contest and the immediate family members, and/or those living in the same household of each such employee, contractor, director and/or officer are not eligible to enter or compete in the Contest.

**Entry:** Enter by completing the entry form at [montereyairport.com/marathon-giveaway](https://montereyairport.com/marathon-giveaway). Contest will run from Friday, March 3 through Wednesday, March 8, 2023. Deadline to enter is 11:59 PM on Wednesday, March 8, 2023. Winners will be selected randomly. The winners will be notified via email on Thursday, March 9, 2023.

By entering, entrants certify that they are available and able to run in the Big Sur International Marathon on Sunday, April 30, 2023 and that they understand that they will be responsible for the coordination and payment of airfare, lodging and all associated travel costs.

By entering, each participant agrees to release, discharge, defend and hold harmless MRY, its parents, subsidiaries, affiliated companies, licensees, and assigns, and its respective officers, directors, employees, agents, and representatives from any claim or liability arising from or related to submitting an entry.

**Contest Prize Package:** Ten (10) randomly selected winners will receive:

- One (1) race entry for the Big Sur International Marathon (Sunday, April 30, 2023)
- One (1) MRY / United running team shirt
- Pre-race dinner for you and a guest at Woody's at the Airport with the MRY/United running team (Friday, April 28, 2023)

Big sur International Marathon registration must be completed by Sunday, March 12, 2023.

Airfare, lodging, and all associated travel costs are not included in the prize package.

**Winners:** A winner of a prize is not declared a winner unless and until the participant's eligibility is verified and confirmed under these Official Contest Rules.

The selection of the winners of the prizes will be final and binding.

There shall be no transfer, substitution, or cash equivalent for prizes except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value if a prize cannot be awarded as described for any reason.

Entrants are responsible for the payment of all taxes applicable to prizes and the award of prizes.

**Prize Redemption:** Winners will be notified via email on Thursday, March 9, 2023. Winner must respond to notification to claim said prize within twenty-four (24) hours of notice or attempted notice.

Winners will be responsible for completing the Big Sur International Marathon registration form by Sunday, March 12, 2023, using the link specified in the notification email.

**Changes/Cancellation:** Management of Monterey Regional Airport reserves all rights to cancel the Contest for any reason that it deems appropriate. No cash value.

**General Terms and Conditions:** MRY shall not be responsible for any failed entries for any reason including without limitation due to malfunction of any network or system, any technical or human error, failures or malfunctions of any kind, lost, late, damaged, delayed, incomplete, illegible, unreadable, or misdirected.

Each contest participant agrees that in the event he or she wins MRY shall have the right, without compensation, to publicize and/or broadcast his or her name, voice, likeness, city of residence and the fact that he or she won the contest. Contest participants further agree that MRY may use such identifying information to publicize on its website and/or other social media outlets.
